

### About us:

The first meeting of the European Knowledge Tree Group for eHealth (EKTG) took place in Denmark in September 2010 followed up by a Symposium at the London School of Economics (LSE) later that year attended by strategically important invited guests.

EKTG has now been based at LSE for nine years. It comprises a widely drawn group including policy makers, designers and implementers, as well as academics, third sector, central and local government, health and welfare professionals, as well as leaders of large and small businesses. The group shares a desire for fundamental change in the way ageing is perceived and eHealth is delivered.

Our cross-EU activity has identified the need for better understanding and implementation of digital and eHealth technologies by us all. We believe that the changing demography coupled with fast evolving mobile technologies creates a huge opportunity for innovation in delivering services in the community, especially to older and disabled people. There is a growing commitment across Europe to rapid deployment of eHealth services. The strategy of those we work with, is for an ageing population and for effective management of chronic conditions.

Nevertheless, although technologies have been extensively trialled and evaluated creating a substantial and growing evidence base, only some EU Member States have yet established such services nationally. eHealth has not reached educational courses or academic curricula to any great extent. Many people in the associated workforce function without any recognised or formal qualifications or cover for legal and ethical matters.

eHealth is now ready to scale up, demanding active knowledge transfers and processfocused understanding. Potential service and supply partners such as health commissioners, social care providers, retail channels and installers must understand each other's concerns and the value innovations that need to be made. Employers are often unaware of the extent of their responsibilities to employees working off-site. Further educational opportunities are needed.

Aim of this Symposium: The main effort will be spent matching opportunities offered by options from, AAL Forum Solutions, the EU Blueprint, UK Government, Healthy Ageing, as recently debated by the HoL Science and Technology Committee as well as associated topics raised in earlier EKTG events. Data is the new gold, but it brings in new and unprecedented issues related to ethics and privacy. Home sensors, geolocalization, and trackers, for instance, provide us with useful knowledge on how to protect and improve the lives of seniors. Digital solutions are rapidly utilized by older adults themselves to measure health conditions, improve lifestyle and a feeling of security and autonomy. Moreover, it can give care and social professionals and companies new tools to develop new solutions and faster implementation. However, the collection of data raises questions about ethics: what type of data is collected and why, for example. Workshops in this theme should focus on topics such as home sensors, professional level, GDPR, data privacy in different countries, and how to overcome the barriers that data privacy represent for development of new solutions.

Data is widely recognised as the 'New Golden Resource' of the 21st Century offering both business and society the prospects of responsive and coordinated services. Cost effective and timely data can and should be used to protect and improve the health and independence of older people, their families and carers.

To innovate a system to support better awareness of the need to improve education and understanding of how technology can assist for a healthier population, and to identify support from others outside EKTG for this. We will ask 'What can you do?'

## Some more information about our Chairman and Contributing Presenters in alphabetical order:

**Baroness Sally Greengross** has been a cross bench (independent) member of the House of Lords since 2000 and co-chairs five All-Party Parliamentary Groups: Dementia, Corporate Social Responsibility, Intergenerational Futures, Continence Care and Ageing and Older People. She is the Vice Chair of the All-Party Parliamentary Group on Choice at the End of Life, and is Treasurer of the All-Party Parliamentary Group on Equalities. She is Chief Executive of the International Longevity Centre – UK; Co-President of the ILC Global Alliance; and was a Commissioner for the Equality and Human Rights Commission from 2006-12.

She was Director General of Age Concern England from 1987 until 2000. Until 2000, she was joint Chair of the Age Concern Institute of Gerontology at Kings College London, and Secretary General of Eurolink Age. She is Chair of the Advisory Groups for the English Longitudinal Study on Ageing (ELSA) and the New Dynamics of Ageing (NDA), President of the Pensions Policy Institute and Honorary Vice President of the Royal Society for the Promotion of Health, Patron of the National Association of Care Caterers (NACC) and Patron of Care & Repair England. She holds honorary doctorates from eight UK universities.

Currently ELFT runs projects like using simple telehealth to monitor patients who are at risk and healed pressure ulcers, using mobile technology health solutions for patients with severe mental illness - a feasiility RCT to name a few.
